1. The Gujarat Metro Rail Corporation (GMRC) has applied for funds from the *Agence Française de Développement* ("AFD") towards the cost of Surat Metro Rail Phase-I Project. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract for "Design, Supply, Installation, Testing and Commissioning of Ballastless Track from Sarthana to Dream City in Elevated and Underground Sections Including Connecting Lines to Depot along with Ballasted / Ballastless / Embedded Standard Gauge Track For Corridor-I, Surat Metro Rail Project, Phase – 1".

The Gujarat Metro Rail Corporation (GMRC) now invites sealed Bids from the eligible Bidders for the "Design, Supply, Installation, Testing and Commissioning of Ballastless Track from Sarthana to Dream City in Elevated and Underground Sections Including Connecting Lines to Depot along with Ballasted / Ballastless / Embedded Standard Gauge Track For Corridor-I, Surat Metro Rail Project, Phase – 1".

The interested bidder has to submit tender fees of INR 25,000/- (Indian Rupees Twenty Five Thousand only) non-refundable in the form of DD/Banker's Cheque along with the bid submission in 1<sup>st</sup> envelope "Initial Filter Cum Qualification Requirement (IFCQR) Bid". No other mode of payment will be accepted.  
  
DD/ Banker's Cheque drawn on a Scheduled Commercial Bank based in India and should be in favour of "Gujarat Metro Rail Corporation (GMRC) Ltd" payable at Gandhinagar / Ahmedabad.
5. Bids must be delivered to the above office on or before *1500 Hrs* on *28-02-2022* and must be accompanied by a tender security and tender fees.
6. Bids will be opened in the presence of bidders' representatives who choose to attend at [*1530 Hrs and 28-02-2022*] at the offices, as mentioned in Para 3 above.
