1. The Gujarat Metro Rail Corporation (GMRC) has applied for funds from the *Agence Française de Développement* ("AFD") towards the cost of Ahmedabad Metro Rail Phase-II Project. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract for ***“DESIGN, MANUFACTURE, SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF MACHINE ROOM-LESS & GEAR-LESS LIFTS (LOT-1) AND HEAVY DUTY ESCALATORS (LOT-2) FOR AHMEDABAD METRO RAIL PHASE-II PROJECT”***.

The interested bidder has to submit tender fees of INR 25,000/- (Indian Rupees Twenty-Five Thousand only) non-refundable in the form of DD/Banker's Cheque along with the bid submission in 1st envelope ***“Initial Filter Cum Qualification Requirement (IFCQR) Bid”***. No other mode of payment will be accepted.

DD/ Banker's Cheque drawn on a Scheduled Commercial Bank based in India and should be in favour of ***“Gujarat Metro Rail Corporation (GMRC) Ltd”*** payable at Gandhinagar / Ahmedabad.
5. Bids must be delivered to the above office on or before 1500 Hrs on 12-07-2022 and must be accompanied by a tender security and tender fees.
