

## Invitation for Bids (IFB)

1. The Gujarat Metro Rail Corporation (GMRC) has applied for financing from KfW toward the cost of the Surat Metro Rail Phase-I Project. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract for "Supply, Installation, Testing and Commissioning of E&M Works for 20 Elevated Stations – Sarthana, Nature Park, Varcha Chopati Garden and Shri Swaminarayan Mandir Kalakunj on Corridor - 1 and Bhesan, Botanical Garden, Ugat Vaarigruh, Palanpur Road, L.P.Swani School, Performing Art Centre, Adajan Gam, Badri Narayan Temple, Majura Gate, Udhana Darwaja, Kamela Darwaja, Anjana Farm, Model Town, Magob, Bharat Cancer Hospital and Saroli on Corridor-2, In Connection With Surat Metro Rail Project, Phase-1, Package EM - 02".
2. The Gujarat Metro Rail Corporation (GMRC) now invites sealed Bids from the eligible Bidders for the Supply, Installation, Testing and Commissioning of E&M Works for 20 Elevated Stations – Sarthana, Nature Park, Varcha Chopati Garden and Shri Swaminarayan Mandir Kalakunj on Corridor - 1 and Bhesan, Botanical Garden, Ugat Vaarigruh, Palanpur Road, L.P.Swani School, Performing Art Centre, Adajan Gam, Badri Narayan Temple, Majura Gate, Udhana Darwaja, Kamela Darwaja, Anjana Farm, Model Town, Magob, Bharat Cancer Hospital and Saroli on Corridor-2, In Connection With Surat Metro Rail Project, Phase-1, Package EM - 02.
3. Bidding will be conducted by means of the International Competitive Bidding procedure with qualification as specified in the KfW Guidelines for Guidelines for Procurement of Goods, Works and associated Services in Financial Cooperation with Partner Countries ("KfW Guidelines").

A complete set of bidding documents may be downloaded from N Procurement portal (i.e. <https://gmrc.nprocure.com> ) and the interested bidder has to submit tender fees of INR 25,000/- (Indian Rupees Twenty Five Thousand only) non-refundable in the form of DD/Banker's Cheque along with the bid submission 1st envelope "Initial Filter Cum Qualification Requirement (IFCQR) Bid". No other mode of payment will be accepted.

DD/ Banker's Cheque drawn on a Scheduled Commercial Bank based in India and should be in favour of "Gujarat Metro Rail Corporation (GMRC) Ltd" payable at Gandhinagar / Ahmedabad.

6. The Bids must be delivered to the above office on or before 1500 Hrs on 12-08-2022 and must be accompanied by a tender security and tender fees. The submission of Bid (i.e. IFCQR, Technical and Price bid) to be made in line with ITB Clause 21 in BDS.
7. In the first public session, only the Qualification Documents (i.e. IFCQR Bid) will be opened in the presence of the Bidders' designated representatives. In the second public session, the Technical Bid of those Bidders who have fulfilled the Initial Filter cum Qualification Requirement Bid (i.e. IFCQR Bid) requirements as per the Bidding Document will be opened. In the third public session, the financial Bids of those Bidders who have fulfilled the Technical Bid requirements as per the Bidding Document will be opened.
