For Station Controller/Train Operator, Junior Engineer, CRA and Maintainer posts eligible candidates must pass the pre-Employment Medical fitness as per the Indian Railway Medical Standards mentioned in Recruitment Notification. (Letter for Medical will be issued on the day of document verification)
5. **The order of selection process for SC/TO post is slightly modified which may please be noted.** Eligible candidates in OMR based examination will undergo psychometric test and successfully qualified candidates in psychometric test will be called for document verification followed by pre-employment Medical fitness test, as per the Indian Railway Medical Standards mentioned in Recruitment Notification.
