1 Introduction

Gujarat Metro Rail Corporation (GMRC) Limited, SPV of Govt. of Gujarat and Govt. of India, invites bids through an e-auction for the sale and disposal of steel parapet scrap materials located at the *SABARMATI RAILWAY METRO STATION OF NORTH SOUTH CORRIDOR OF AHMEDABAD METRO RAIL PROJECT PHASE 1*. The materials are offered on an "as-is-where-is" basis, and bidders are expected to adhere to the terms and conditions outlined in this tender document. The auction is conducted to dispose of various steel parapet scrap materials, including but not limited to scrap metal, and other miscellaneous items. This e-auction aims to ensure transparent and competitive bidding for the disposal of salvage materials in an environmentally responsible manner.

2 Tender Details

3 Description of Steel Parapet Scrap Materials

The steel parapet scrap materials available for sale include, but are not limited to, the following:

Note: Bidders are advised to inspect the materials during the designated inspection period to assess the steel parapet scrap Materials and their condition where stacked in-front of Grid 1 to 4 & near Grid 16. i.e. at two different locations within premise of Sabarmati Railway Metro Station.

4 Cost of Works and Reserve price

The approximate cost of works / reserve price / bid price for segregation, environmental assessment, and auction- related activities is INR 10,00,000/- (Quantity Approximately 40 MT and base rate INR 25,000/- per ton), excluding the GST and TCS.

5. Site Inspection

- All the material offered for sale is on “AS IS WHERE IS” basis and where this is laid. Material is sold on the assumption that bidders have inspected the same and know what they are buying, irrespective of whether they have first inspected the materials or not. No complaint shall be entertained in this regard.
- The Bidders will have to inspect the material thoroughly and satisfy themselves about the nature, before submitting the bid.

6 Eligibility Criteria for Bidders / Submission of Technical Bid

Bidders must meet the following criteria:

- Submission of Tender fees, EMD amount, Certificate of incorporation of proprietary firm / company and Valid GST registration. (Refer Annexure – 1)
- Undertaking of No Legal Disputes: No litigation or blacklisting by any government entities. (Refer Annexure – 2)
- The bidder will require to submit the signed / stamp copy of this auction notice / tender document as token of acceptance of all terms and conditions.
- The bidder will required submit their Account details in Annexure – 3 for release of EMD / Tender Security Amount.

7 Scope of Work

The successful bidder, who has quoted the highest bid, shall be responsible for:

- a) The successful bidder will require to pay the bid amount + GST & TCS as applicable via DD / NEFT in favour of "Gujarat Metro Rail Corporation Limited" payable at Gandhinagar within 02 days of issue of order by GMRC for sale / disposal of salvage materials (steel parapet scrap materials).
- b) Removing all steel parapet scrap materials / Disposing of scrap materials from two different locations within premise of Sabarmati Railway Metro Station Project site within 14 days of the receipt of all payment of the salvage material.
- c) Ensuring safe handling, loading, and transportation of materials without causing damage to the premises.
- d) Bearing all costs associated with labour, equipment, transportation, and disposal.
- e) Joint verification of the weight of materials shall be carried out in the presence of representatives of GMRC and the vendor. The vendor shall be solely responsible for making all necessary arrangements for weighing and shall bear all associated costs.
- f) Obtaining necessary permits for transportation and disposal, if required.
- g) Upon completion of the sale process, the successful bidder/agency shall be required to submit a certificate detailing the final use or disposal of the material (i.e., whether disposed of, reused, or refurbished), ensuring that all actions are carried out in an environmentally sound manner.

8 Vary of Quantities:

- a) The estimated quantity of scrap material as stated in the tender document is purely indicative in nature & is arrived at based on physical inspection of various GMRC site / offices. The exact quantity of waste / scrap may vary at the time of actual disposal.
- b) Any additional cost for measurement of quantity will be borne by the successful agency.
- c) On completion of Auction Process and issuance of LoA, the successful bidder will require to pay 100% Advance Payment to GMRC in two days of time.
- d) Subsequently, the final payable amount for each item / lot will be calculated based on actual quantity of scrap material verified during pickup (by joint measurement by GMRC and successful bidder). This amount will be adjusted against the advance payment already made. Further, any difference in the total sale value (increase or decrease) after completion of the work will be recovered from or refunded to the bidder within 02 days of time on completion of verification process. If the bidder fails to lift the scrap material within the stipulated time, the EMD will be forfeited.
- e) The updated rate/quote per ton and verified quantity will be used to calculate any adjustment in the sale price.

9 Bidding Process

- a) The bidder will require to register on <https://e-auction.nprocure.com/> portal to participate on e-auction.
- b) The interested bidder will be required to submit their bid (i.e. EMD, Annexures 1 & 2, Signed copy of tender document) in physical / offline mode in due timeline (Refer Clause – 2) at GMRC's office as mentioned below.

- c) The bid should be submitted in physical / offline form on or before the last date and time of bid submission by RPAD / Speed Post/ Courier/ Hand delivery. GMRC will not be responsible for non-receipt of tender submission as mentioned above due to any delay and/or loss etc
- d) Late submission of bid will not be accepted.
- e) The bidder, who fails to submit the offline bid in due time line, will not be considered for participation in E-Auction on <https://e-auction.nprocure.com/> portal.
- f) The offline / physical bid submitted by the bidder will be opened on same day of bid submission at 15:30 Hrs.
- g) The qualified agency will be informed the date and time of e-auction and further participation.
- h) The auction will be conducted with qualified bidder on e-procurement portal <https://e-auction.nprocure.com/>).
- i) The agency to note that they must submit the rate on <https://e-auction.nprocure.com/> for all the items / materials available at site.
- j) During the E-Auction, the bidder will have to bid the amount in the minimum increment (i.e. INR 10,000/-) or multiple of the bid amount as per the base price / reserve. In case of any bid amount during the last 5 minutes of the e-auction closing time, the closing period of the bid process will automatically increase in 5 minute slabs. Accordingly, the bid process will be declared complete only after the last 5 minutes have passed without any bid increment (higher bidding instant).
- k) The name of any bidder participating in the bidding process will not be disclosed during the e-auction process. Only the bidder himself will be able to know in his log-in that the bidder is the highest bidder in that bid..
- l) During the auction the bidders are also advised to click “Refresh” link for refreshing their webpage to get the latest information about the status of the auction. The Live Auction window will remain same and also time remaining will be ticking, even in the event of disconnection of bidder’s computer system, Network/Internet. The bids submitted by other bidders during the time of disconnect of bidder computer system will not be displayed on your screen. The other bidder might have become H1/H2 (as the case may be) for the item during this time. To overcome this situation the bidders are also advised to click “Refresh” link for refreshing their webpage frequently.
- m) Internet connectivity and other paraphernalia requirements shall have to be ensured by bidder themselves. In order to ward-off such contingent situation like internet connectivity failure, power failure etc., bidders are requested to make all the necessary arrangements / alternatives whatever required so that they are able to circumvent such situation and still be able to participate in the live auction successfully. However, the bidders are requested not to wait till the last moment to quote their bids to avoid any such complex situations.
- n) The last (latest) successful bid price (highest bid) quoted by the bidder will be considered as valid price after closing of Auction time.

10 Terms and Conditions

- a) Conditional Bid shall be treated as invalid. No Bidder shall be allowed to participate in the auction without remitting Tender fees and EMD Amount.
- b) The validity of this bid will be 90 days from the date of submission of bid.
- c) Bidding will start from the reserve rate (i.e. INR 10,00,000/-). Bidding shall be done in multiples of INR 10,000/- or such amount as decided by the GMRC.
- d) The bidder quoting the highest price shall be declared as the successful bidder, subject to the conditions detailed herein.
- e) The Bid once made by the bidder cannot be cancelled or withdrawn and the bidder shall be bound to buy the movables, if the bid is accepted in their favour. If the bidder withdraws his bid or fails to honour his commitment the EMD will be forfeited.
- f) The EMD of the unsuccessful bidders shall be returned on completion of auction proceedings. The EMD of the successful bidders shall be returned on completion of total payment and transfer / loading of all materials from the site.
- g) The Successful bidder shall pay / remit the final bid amount along with applicable GST and TCS in favour of Gujarat Metro Rail Corporation (GMRC) Limited, in two days of the sale being confirmed in their favor, failing which the next highest bid will be considered for declaration as the successful bidder.
- h) The successful bidder/purchaser shall bear all the transfer, transportation charges, dismantling expenses etc., and also all the statutory/ non-statutory dues, taxes, transfer fees, other fees etc., if any w.r.t. said movables or any other incidental charges with respect to the Sale.
- i) The Physical possession of the auctioned movables shall be handed over to the successful bidder/ purchaser only after receipt of full purchase price. The successful bidder, i.e. purchaser shall be liable for taking away the movables and clearing GMRC premises within 14 working days from the date of auction. Delay if any, in clearing the premises or delay in payment will attract a penalty of Rs. 5000/- per day till the date of clearing / payment.
- j) Safety: The Bidders shall ensure compliance with safety protocols, including the mandatory use of Personal Protective Equipment (PPE) and adherence to OSHA standards. GMRC shall not be held liable for any accidents or injuries arising during the site inspection or loading / unloading of materials. Therefore, the successful bidder will be required to take necessary insurance as applicable.
- k) GMRC will have right to forfeit the EMD amount in case successful bidder fails to pay the sale amount including GST & TCS.
- l) GMRC may cancel the auction at any time due to any reason whatsoever. In such case EMD of all the bidders shall be returned.
- m) Dispute Resolution: The contract and the relationship of the parties hereunder shall be governed by and interpreted in accordance with the laws of India and parties hereby agree to submit that the court at Gandhinagar, Gujarat shall have the exclusive jurisdiction to dispute if any arising between the parties to the Contract.
- n) The tender / auction detail is drafted in two languages (i.e. Gujarati & English), in case of any ambiguity between the two, the tender drafted in English will prevail.
- o) The decision of GMRC will be final and binding to the bidder with respect to acceptance of bidder's quote.
