1 Introduction

4 Submission of Sealed Bid

4.1 The prospective agency / firm / company/ proprietor / individual to participate in E-Auction shall require to submit the following document before the due date and time.

- Submission of Annexure – 2, Undertaking.
- Submission of Annexure – 3, the account details of participant for refund of EMD / tender security amount
- The bidder will require to submit the signed / stamp copy of this auction notice / tender document as token of acceptance of all terms and conditions.

4.2 The interested bidder will be required to submit above mentioned documents in physical / offline mode in due timeline at GMRC's office as mentioned below.

4.3 The bid should be submitted in physical / offline form on or before the last date and time of bid submission by RPAD / Speed Post/ Courier/ Hand delivery. GMRC will not be responsible for non-receipt of tender submission as mentioned above due to any delay and/or loss etc.

4.4 Late submission of bid will not be accepted. The validity of this bid will be 90 days from the date of submission of bid.

4.5 The offline / physical bid submitted by the bidder will be opened on same day of bid submission at 15:30 Hrs.

5 E-Auction / Bidding Process

- 5.1 The bidder / agency will require to register on <https://e-auction.nprocure.com> portal to participate on e-auction.
- 5.2 The bidder, who fails to submit the offline bid and the details as mentioned in Clause 4 in due time line, will not be considered for participation in E-Auction on <https://e-auction.nprocure.com> portal.
- 5.3 The qualified agency will be informed the date and time of e-auction on <https://e-auction.nprocure.com> portal.
- 5.4 The agency to note that they must submit the rate on <https://e-auction.nprocure.com> for the vehicle they want to purchase. The agency can either participate in e-auction process for purchase of both vehicles as mentioned in Table-A or any one or two vehicles as per their choice.
- 5.5 The H-1/successful bidder will be decided per vehicle.
- 5.6 Bidding will start from the reserve rate as mentioned in Table - A. Bidding shall be done in multiples of INR 5,000/- or such amount as decided by the GMRC.
- 5.7 Conditional Bid shall be treated as invalid. No Bidder shall be allowed to participate in the auction without remitting Tender fees and EMD Amount.
- 5.8 During the E-Auction, the bidder will have to bid the amount in the minimum increment (i.e. INR 5,000/-) or multiple of the bid amount as per the base price / reserve. In case of any bid amount during the last 5 minutes of the e-auction closing time, the closing period of the bid process will automatically increase in 5 minute slabs. Accordingly, the bid process will be declared complete only after the last 5 minutes have passed without any bid increment (higher bidding instant).
- 5.9 The name of any bidder participating in the bidding process will not be disclosed during the e-auction process. Only the bidder himself will be able to know in his log-in that the bidder is the highest bidder in that bid.
- 5.10 During the auction the bidders are also advised to click "Refresh" link for refreshing their webpage to get the latest information about the status of the auction. The Live Auction window will remain same and also time remaining will be ticking, even in the event of disconnection of bidder's computer system, Network/Internet. The bids submitted by other bidders during the time of disconnect of bidder computer system will not be displayed on your screen. The other bidder might have become H1/H2 (as the case may be) for the item during this time. To overcome this situation the bidders are also advised to click "Refresh" link for refreshing their webpage frequently.
- 5.11 Internet connectivity and other paraphernalia requirements shall have to be ensured by bidder themselves. In order to ward-off such contingent situation like internet connectivity failure, power failure etc., bidders are requested to make all the necessary arrangements / alternatives whatever required so that they are able to circumvent such situation and still be able to participate in the live auction successfully. However, the bidders are requested not to wait till the last moment to quote their bids to avoid any such complex situations.
- 5.12 The bidder quoting the highest price shall be declared as the successful bidder, subject to the conditions detailed herein.
- 5.13 The Bid once made by the bidder cannot be cancelled or withdrawn and the bidder shall be bound to buy the movables, if the bid is accepted in their favour. If the bidder withdraws his bid or fails to honour his commitment the EMD will be forfeited.

- 5.14 GMRC will have right to forfeit the EMD amount in case successful bidder fails to pay the sale amount including GST & TCS.
- 5.15 The EMD of the unsuccessful bidders shall be returned on completion of auction proceedings. The EMD of the successful bidders shall be returned on completion of the ownership transfer process.
- 5.16 The Successful bidder (i.e. H1) shall pay / remit the final bid amount with applicable GST and TCS in favour of Gujarat Metro Rail Corporation (GMRC) Limited within seven days from the date of issuance of the Letter of Acceptance (LOA). In case, the successful bidder fails to pay the due amount, the bidder will be debarred from participating in future tenders for a period of 1 year from the date of cancellation of LOA.

Further, GMRC, at its sole discretion, may offer the opportunity to the next highest bidder (i.e., H2) to purchase the vehicle at the H1 bid price.

- 5.17 The Successful Bidder shall be solely responsible for Registration, transferring the ownership of the vehicle in their name and for updating the Registration Certificate (RC Book) at their own cost in accordance with applicable laws and regulations. The Photo copy of the New Registration Certificate & other related documents should be given to the GMRC before taking possession of the vehicle.
- 5.18 The sold vehicle shall have to be removed by the successful bidder at his own cost. The successful bidder/purchaser shall bear all the transfer, transportation charges, etc., and also all the statutory/ non-statutory dues, taxes, transfer fees, other fees etc., or any other incidental charges with respect to the Sale. The successful bidder shall complete the ownership transfer process within 07 days from the date of payment.
- 5.19 It is the responsibility of the successful bidder for arranging transfer of ownership, insurance and tax etc. of the vehicle purchased in the records at his cost.
- 5.20 GMRC will be discharged from its liability from the date of sale of vehicle.
- 5.21 GMRC may cancel the auction at any time due to any reason whatsoever. In such case EMD of all the bidders shall be returned.
- 5.22 Further "Addendum" (if any) shall be issued on GMRC's website & E – Auction portal only and bidder has to refer the same before final submission of the Tender.
- 5.23 Dispute Resolution: The contract and the relationship of the parties hereunder shall be governed by and interpreted in accordance with the laws of India and parties hereby agree to submit that the court at Gandhinagar / Ahmedabad, Gujarat shall have the exclusive jurisdiction to dispute if any arising between the parties to the Contract.
- 5.24 The tender / auction detail is drafted in two languages (i.e. Gujarati & English), in case of any ambiguity between the two, the tender drafted in English will prevail.
- 5.25 After E-Auction, the decision of GMRC will be final and binding to the bidder with respect to acceptance of bidder's quote.
